Amendment to the List of "Consent Exempt Industries or Industries Not Requiring Consent of Pollution Control Board, Assam"

As per the decision taken in 96th Board Meeting, the Pollution Control Board, Assam notifies the following amendments to the list of the Consent Exempt Industries or Industries not requiring Consent of the Board Notified vide No WB/G-907/13-14/03 dtd. 01.10.2013 –

2	Workshop for vehicle repair.	Exemption to be allowed for investment upto Rs. 5.00 lakhs on plant & machinery only.
3	Engineering workshop, machine shop, fabrication shop, press shop, smithy shop, turning shop, cutting shop.	DO
9	Units fabricating nails, pegs, nuts, bolts, etc.	Exemption upto investment limit of Rs. 7.00 lakhs on plant & machinery only
10	Units manufacturing utensils of aluminum, steel, copper, brass and bell metal.	DO
12	Units fabricating iron doors and shutters.	Exemption to be allowed for investment upto Rs. 10.00 lakhs on plant & machinery only.
13	Units fabricating steel furniture without electroplating.	DO
21	Units making paper napkins, dishes, labels, tallow, paper rolls.	Exemption for non integrated types only i.e these items are to be made from finished product only
24	Units manufacturing electric fans, tube lights, bulbs, lamps, fuses, switches, etc.	Exemption upto investment limit of Rs. 7.00 lakhs on plant & machinery only
32	Units manufacturing plastic items like buckets, tumblers, footwear, brushes, ropes.	Exemption allowed upto the total investment limit of Rs. 20.00 lakhs with virgin plastic as raw material
33	Unit producing plastic items through fabrication, extraction, injection moulding methods.	DO
34	Units making leather items like bags, purses, wallets, etc. from ready leather.	Exemption for goods made from finished leather only.
38	Cold storage.	Exemption allowed upto Investment limit of Rs. 20.00 lakhs only on plant & machinery
39	Domestic flour mills.	To be renamed as "Atta Chakki Mills".
40	Units grinding coriander, cumin, turmeric and spices.	To be renamed as "Cottage industries grinding coriander, cumin, turmeric and spices".
42	Printing presses.	Exemption allowed upto the investment limit of Rs. 10.00 lakhs only on machinery
43	Rice mills including rice puff manufacturing.	To be renamed as "Hauler Mill".
46	Poultry farms and dairy farms.	Exemption for units having upto 100 birds &/or 30 animals only.
48	Induction furnaces.	Exemption allowed upto the investment limit of Rs. 10.00 lakhs only on machinery
52	Units retreading tyres.	Exemption for cold type retreading only.
53	Units manufacturing rubber parts, rubber corks, surgical gloves.	Exemption for non integrated types only i.e these items are to be made from finished product.

General:

In respect of other industries included in the Exempt Category list but not covered under Item Nos. stated above in this Notification, the exemption shall be applicable in respect of such industries provided that the total investment in such industries is below Rs. 10,00,000/- (Rupees ten lakhs) only, however, the requirement of obtaining "Consent" from the Board shall be applicable.
