TERMS & CONDITIONS:

- a) Each bidder shall submit the following self attested document alongwith the bid – (i) two copies of passport size photo; (ii) One photocopy of PAN Card; (iii) Proof of Address; (iv) Identity Proof; (v) Mobile Number/email address.
- b) Bidders must submit offers for all items and must offer rates for each item and shall also submit Bid Security as mentioned at Sl. No. 1.
- c) Bids without accompanied by the requisite bid security as mentioned above shall be rejected.
- d) Bidders offering highest amount in total shall be declared as winning bid, provided they meet all the stipulated terms and conditions.
- e) Winning bidders, upon informed by the Member Secretary, Pollution Control Board, Assam shall have to deposit the full amount of the offered price in the form of Demand Draft in favour of Member Secretary, Pollution Control Board, Assam payable at Guwahati within 7 (seven) days from the date of issuance of intimation letter by the Member Secretary, Pollution Control Board, Assam failing which such bids shall be cancelled and the bid security amount shall be forfeited and the next highest offer will be considered.
