## Office Order

**Sub: Establishment of State Control Room to monitor enforcement of SUP Ban.**

1. A State Control Room (SCR) to monitor enforcement of SUP ban in the state of Assam has been established in Pollution Control Board Assam (PCBA) in accordance with decisions taken by the national Task Force in its 3<sup>rd</sup> meeting held on June 26, 2022.
2. The SCR shall become operational w.e.f. July 01, 2022 and facilitate activities related to effective implementation of SUP ban including the following:
  - (a) Provide assistance, guidance, clarification and information as may be sought by various stakeholders regarding ban on SUP items, which may include but not limited to the following:
    - Specific items covered under/ excluded from SUP Ban.
    - Alternative to banned SUP items and their availability in Assam.
    - Guidance for filling of complaints on SUP Public Grievance App.
    - Guidance for operation of SUP compliance monitoring portal by ULBs.
    - Issues related to switching over to alternatives including issue of Consent/registration of plastic producers.
    - Compostable Plastic manufacturers: (certification procedure, testing facilities etc.)
  - (b) The SCR shall monitor enforcement of SUB ban through ULBs and Regional offices of PCBA.
