The Pollution Control Board, Assam hereby notify that henceforth no "Consent to Operate" certificate shall be issued with retrospective effect in any case. All "Consent to Operate" certificate shall be issued with prospective effect only.

Therefore, all concerned those who requires "Consent to Operate" certificate of this Board under Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and Section 25 of Water (Prevention & Control of Pollution) Act, 1974 are directed to apply for "Consent to Operate" for the session 2015-16 within November, 2015 positively without fail. Operation of any industry, health care facility, treatment plants or any other process having either emission or discharge or both without "Consent to Operate" certificate will be dealt with as per provision of enforcing Acts & Rules.

"Consent to Operate" certificate for the next year onwards, application should be submitted 4 (four) months before commencement of the year / session (1<sup>st</sup> April to 31<sup>st</sup> March).
