OPERATION OF INDUSTRIAL UNITS IN GENERAL AND SPECIFICALLY HOTEL / LODGE / RESTAURANT / DHABAS / RESORTS / BANQUET HALLS / BANQUET PREMISES / BAKERY / CONFECTIONERY / SWEET PRODUCT MANUFACTURING / AUTOMOBILE SERVICING STATIONS / WORKSHOP & OTHER THEREOF WITHOUT CONSENT

It has come to the notice of the Board that many units belonging to various categories including service sectors are establishing and operating without obtaining prior consent of the Pollution Control Board, Assam as mandated under the provisions of Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Rules made thereunder thereby not complying with the various environmental norms and standards causing environmental pollution in the surroundings.

By this notice all the entrepreneur of Hotel/Lodge / Restaurant / Dhabas / Resorts / Banquet Halls / Banquet Premises / Bakery / Confectionery / Sweet Product Manufacturing / Automobile Servicing Stations / Workshop vis-à-vis other industrial units operating / functioning without prior permission of the Board in the State of Assam are hereby once again directed to make an application for grant of consent under the provisions of Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 as applicable within 15 (fifteen) days from the date of publication of this notice.

Failing to comply with the abovementioned legislations, the Board will be constrained to initiate appropriate legal proceedings, which may include prosecution and Closure of the units/establishments alongwith disconnection of electricity, water supply or any other essential services as per the provision laid down in Water, Air and Environment (Protection) Act which may please be noted.
