As per information collected during the field visit and inspection of the site, the following observations are made :-

i. M/s B B A bricks, Sativeti, Mayong is present as intimated by the complainers. The Stack is present with kiln. The Kiln of the brick industry is seen in a dilapidated condition. The whole site of the brick kiln looks like an abandoned area. No activities were seen around the brick kiln at this moment.

ii. The apprehension of villagers regarding emission, loss of agricultural land, grazing land bio-diversity of this area cannot be ruled out if the area is converted to industrial area.

Comment

The site of M/s B B A Bricks, Sativeti, Mayong, Morigaon is an abandoned area.
