Pollution Control Board, Assam on behalf of Govt. of Assam invites "Expression of Interest" from capable & experienced firms/companies for "Setting up and operating ICWTSDRF (Integrated Common Waste Treatment, Storage, Disposal & Recycling Facilities) including Incineration for the state of Assam" subject to obtaining Authorization & Registration from Pollution Control Board, Assam as per the relevant provisions of the Hazardous Wastes (Management, Handling & Trans boundary Movement) Rules, 2008, Bio-Medical Waste (Management & Handling) Rules, 1998, E-Waste (Management & Handling) Rules, 2011 and the provisions of Environment (Protection) Act, 1986 as amended till date.

The Government of Assam has allotted approximately 50 acres of land at Geleki in Sivasagar district for the said purpose on lease basis for 99 years.
