2. Aims and objectives

2.1 Background

With the changing lifestyle and urbanisation, the plastic wastes generated are increasing exponentially. The single use plastic (SUP) forms a large part of the plastic waste generated. The plastic Waste management (amendment) rules 2021 has been notified by the Govt. of India vide notification No.G.S.R 571(E) dtd 12th of August 2021. The said rules have identified certain single use plastic commodities based on their utility factor and littering potential. The rules prohibit manufacture, sale, stock and use of the identified single use plastic items with effect from 01/07/2022. The Govt. of Assam has prepared a comprehensive action plan for phasing out identified single use plastic items within the time frame stipulated in the said rules. There is an urgent need to identify and quantify all the single use plastics available in the markets in Assam as well as their manufacturers for proper plastic waste management.

2.2 Scope of the project

- 1. To carry out a detailed survey to identify the single use plastics, carry bags and pouches (as specified by the Board) available in the markets of the state.
- 2. To identify all prohibited plastic items (list of items to be provided by the board) available in the markets.
- 3. To identify the source/manufacturer of all plastic carry bags and single use plastics available in the markets.
- 4. Quantification and characterization of plastic wastes from residential areas, commercial areas, littering hotspots etc.
- 5. Inventorization of all plastic producers and recyclers in the state.
- 6. Verification of EPR implemented by producers and brand owners.
- 7. Validation and submission of final reports as per the requirements of PCBA.

The Scope of work specified in this EOI are not exhaustive and the agency/organisation shall undertake such other tasks as may be necessary for a satisfactory final report.

3. Expected Deliverables of the Assignment

- 1. The assignment shall be for a period of 70 days and the key deliverables shall be as follows:
 - a) Completion of field surveys and submission of interim report
 - b) Submission of draft final report as per requirement of PCBA
 - c) Submission of final report after incorporating modifications suggested by the Board.
- 2. The market survey for SUPs has to be conducted with adequate sample size (as specified by Board) and the reports may be submitted as per the format given below.

6.2 Minimum Qualification criteria

- 1. The bidder must be a research institute, waste management agency, consultancy firm or an NGO registered under relevant act.
- 2. The Bidder must have experience in field surveys, data collection, CAPI (Computer assisted personal interviews) etc.
- 3. The bidder must have adequate and qualified manpower.

6.3 Evaluation

The selection of bidder will be based on quality and cost based selection (QCBS). The evaluation would consist of the following stages:-

- A. Evaluation of Technical Bid with 50% weightage.
- B. Evaluation of Financial Bid with 50% weightage.

6.5 Amendment in EOI

6.6 Contract Agreement

The 50 % payment will made to the selected bidder after interim report submission and remaining 50% payment will be made after final report submission, along with the relevant deliverables. Both payments will be done by ECS form only as mentioned in Format.

8. Termination of the assignment.
