**ORDER**

Seen this office order vide No. SVRS.51/2006/102 dtd.1<sup>st</sup> April, 2010 which was issued in pursuance of the Govt. approval communicated vide letter No.RSS.1253/2006/pt/48 dtd.16/03/2010 regarding handing over possession of land measuring 100 (One hundred) bighas of Deopani N.C. Block village under Dupdor Mouza of Amguri Revenue Circle allotted in favour of Pollution Control Board, Assam for construction of Common Treatment Storage & Disposal Facility (CTSDF).

Also seen the minutes and guidelines issued related to NGT order dtd. 25/07/2019 in compliance of O.A. No. 804/2017 dtd. 12/4/2019 & O.A. No. 606/2018 dtd.17/05/2019.

Also seen the Govt. letter received from the Revenue & D.M. Department vide No. RSS.1253/2006/pt/56 dtd.30/10/2013 regarding encroachment over aforesaid land and report of the Circle Officer, Amguri vide letter No. AC/Revenue/12/2013/537 dtd.29/07/2019 whereas it is reported that land measuring 30 (Thirty) bighas out of 100 (One hundred) bighas land of Deopani N.C. Block village under Dupdor Mouza of Amguri Revenue Circle allotted in favour of Pollution Control Board, Assam for construction of Common Treatment Storage & Disposal Facility (CTSDF) was identified in presence of the representative of Pollution Control Board .

Due to urgency of the matter, self visited the location alongwith Addl. Deputy Commissioner & i/c Sub-Divisional Officer (C), Nazira / Circle Officer, Amguri / Executive Engineer, Pollution Control Board on 26/07/2019 and identified the site originally proposed for the purpose which was found unoccupied as on date. The Circle Officer, Amguri Revenue Circle is hereby directed to hand over the aforesaid land measuring 30 (Thirty) bighas of Deopani N.C. Block village under Dupdor Mouza of Amguri Revenue Circle and correct the land records accordingly after handing over possession of the said land to the concerned department and submit report.
