TERMS AND CONDITIONS OF EOI :-

1. The EOI applicant should have valid Registration under the Govt./ Semi-Govt./Autonomous body and must be operational in the same field for the last three (3) years.
2. Self attested photocopy of valid Registration certificate must be furnished alongwith the EOI.
3. The applicant should have the knowledge & expertise of having rendered similar type of consultancy services.
4. Self attested photocopy of Experience certificate alongwith Work order copy must be furnished alongwith the application.
5. The applicant should furnish photocopy of self attested GST Registration certificate and PAN card of the individual/firm.
6. The offered rates, inclusive of GST , should be in % of the estimated value for each work mentioned in the EOI. Rate should be quoted both in figure and in words, in a sealed envelop.
7. The undersigned reserves the right to accept or reject any or all EOIs without citing any reason thereof & also not bound to accept the lowest quoted rate.

Specific conditions :-

- i) Rooftop Canteen/ cafeteria should have seating capacity of at least 20 persons at a time and should be equipped with modern furniture & fixtures and kitchen appliances.
- ii) Acoustics in the Conference hall & VC room should be sound proof with installation of good quality Audio system .
- iii) Coloured pavers block for an area measuring about 200 sq.m should be laid in the vehicle parking shed and in the entrance of the office building.
- iv) Wall mounted Cabinet should be made of 19mm Ply board laminated with high quality Sunmica with provision of installation of AC in few rooms.
- v) Washrooms should be renovated with modern & sophisticated sanitary fittings and existing laboratory washrooms are to be converted into ladies toilet with necessary fittings.
