The quotation received will be opened on the same date at 3.00 PM in presence of the quotationers or their authorized representative who like to be present. Quotations sent by post/courier service received after 2.30 pm on 01.09.2017 shall not be considered for participation.
2. The undersigned reserves the right to reject any or all the quotations in full or in part without assigning any reason thereof.
3. Rates are to be quoted both in words and in figures and in case of any discrepancy the rate quoted in words shall be taken as correct. Each page of quotation shall have to be signed and every correction dully initialed.
4. The rates shall be inclusive of all taxes, loading & unloading and transportation etc. of all the materials to site.
5. The contractor shall arrange all the plants, equipments, machineries, etc. required for the work to site for which no extra charges will be paid.
6. The validity period of the quotation should be clearly mentioned. Rate should be valid upto 3 (three) months.
